



## Understanding the Ongoing Israel-Hamas Conflict: A Comprehensive Overview





#### REGIONAL RAMIFICATIONS AND PROXY WARFARE

The conflict's regionalization has further complicated efforts to de-escalate tensions. Regional actors, including Hizbollah in Lebanon and Iran-backed militias in Iraq, have shown solidarity with Hamas by launching attacks on Israel. Additionally, Yemen's Al-Houthis have disrupted maritime commerce in the Red Sea through targeted attacks on shipping, exacerbating global economic concerns.

Middle East: Tensions likely to ease in the Middle East after Israel's attack inside Iran April 19. Residual disruptions likely through April 30. Geopolitical tensions will likely ease in the Middle East following Israel's strike against a military base in Iran's Esfahan Province early April 19. Israel's anticipated retaliatory strike came a few days after Iran launched 331 drones and missiles against the country on April 13.

Moreover, disruptions in maritime trade routes, particularly in the Red Sea and the Gulf of Aden, have led to significant economic repercussions, including disruptions to supply chains and increased insurance costs.



## Analyzing the Americas: Navigating Elections and Crime



#### THE US ELECTION: A HIGH-STAKES REMATCH

The specter of criminal influence looms large, casting a shadow over neighboring nations like Ecuador, where Mexican groups wage proxy wars through local criminal networks. This internationalization of the drug trade poses a multifaceted threat, from heightened security risks to increased incidents of extortion and kidnapping targeting businesses and individuals alike.



#### Exploring Key Risks in Europe for 2024

In the realm of European geopolitics, two pivotal issues stand out prominently for the year 2024: the persistent conflict in Ukraine and Turkiye's shifting role on the global stage.

#### THE ONGOING CONFLICT IN UKRAINE

Since Russia's invasion of Ukraine two years ago, the conflict has continued unabated, drawing significant attention from the global community. Christian Contro, our lead analyst on Ukraine, predicts that Western sanctions on Russia and its allies will escalate in the coming year. Despite these sanctions, some entities may persist in business dealings with Russia, leading to sanctions evasion. The EU and US are expected to intensify efforts to curb technology and material transfers to Russia, anticipating further rounds of sanctions and reciprocal measures from Russia.




#### TURKIYE'S DOMESTIC AND FOREIGN POLICY CHALLENGES

In Turkiye, domestic factors exert a profound influence on foreign policy decisions. President Erdogan's primary focus in 2024 is stabilizing the economy and consolidating internal support amid regional conflicts and terrorism threats. Turkiye's strategic location at the crossroads of Europe and Asia complicates its relations with NATO, the EU, and neighboring states. Despite tensions, Erdogan adopts a diplomatic approach that balances Western criticism with engagement opportunities. Turkiye's close ties with Russia offer economic and geopolitical advantages, shaping its regional influence.








#### RANSOMWARE: THE EVER-EVOLVING THREAT LANDSCAPE







#### UNPRECEDENTED WARMING TRENDS: A RECAP OF 2023

In recent years, discussions surrounding climate change have become increasingly urgent and unavoidable. The evidence is clear: our planet is warming at an alarming rate, with profound consequences for ecosystems, societies, and economies worldwide. The year 2023 marked a significant milestone, being officially confirmed as the hottest year on record. Forecasts for 2024 suggest that this trend may continue, raising concerns about the long-term implications of rising global temperatures.

#### DYNAMICS OF TEMPERATURE RISE

Temperature increases are being driven by dynamic factors. The nonlinear nature of temperature rise emphasizes that the overall trend is upward; fluctuations occur year by year. In particular, 2023 saw a notable spike in global temperatures, setting records for consecutive hot days and unprecedented warmth across various months. These record-breaking trends have continued into early 2024.






#### IMPLICATIONS AND CHALLENGES: BEYOND THE STATISTICS

The implications of this warming trend extend beyond mere statistics. They challenge international agreements like the Paris Agreement, which aims to limit global warming to well below two degrees Celsius above pre-industrial levels. The realization that 2023 approached the 1.5-degree threshold underscores the urgency of addressing climate change before irreversible consequences unfold.

#### **PROJECTIONS FOR 2024: CONTINUING THE TREND**

Looking ahead, projections for 2024 suggest a continuation of this trend, with potential challenges posed by shifting El Niño-Southern Oscillation (ENSO) phases. The lingering effects of the weakening El Niño will likely see record-breaking temperatures persist well into 2024 before a transition to a cooler La Niña phase during the second half of the year. Overall, 2024 is almost certain to be amongst the top five hottest years on record and could possibly challenge the record recently set during 2023.
